MEMORANDUM OF UNDERSTANDING (MOU)

MEMORANDUM OF UNDERSTANDING (MOU) is entered into on the 12th July 2023 by and between **ISKCON** (here in after referred to as "**ISKCON**") located at Soro, Balasore and **BALASORE COLLEGE OF ENGINEERING AND TECHNOLOGY**, (here in after referred to as "**BCET**") located at Sergarh, Balasore.

WHEREAS ISKCON and BCET wish to work together to provide Universal Human Values for student's skill development and encourage quality in learning so that the students which they serve may make the most meaningful contribution to society through the maximization of their individual personal potentials and achievements.

NOW THEREFORE THIS MEMORANDUM OF UNDERSTANDING WITNESSES AS FOLLOWS:

RESPONSIBILITIES

To achieve the objectives setout above the parties carryout the following activities and the collective responsibilities

1. ISKCON:

- i. Provides Universal Human Values for BCET students.
- ii. Mentoring students in BCET.
- iii. Assist with programs in several skill and capacity building areas benefitting BCET students.
- iv. Facilitate to conduct seminars, workshops, training programs, demonstrations etching the existing infrastructure. A nominal fee shall be collected from the first party for these activities in terms of travel expenses.

2. BCET:

BCET shall create awareness amongst its students for promotion of the activity especially Universal Human Values training program.

TERMS OF MOU

This MOU shall be operational and valid from 12th July 2023 for three (3) years tenure with BCET, and upon completion of the three years, the agreement can renewed with mutual consent of both parties.

CERTIFICATION

Upon completion of the Universal Human Values, Ethical and Spiritual training, ISKCON will conduct assessment for students and staff. The students and staff qualifying the assessment shall be certified with completion certificate.

RELATIONSHIP

This MOU relates solely to the intention of the parties, wherein BCET and ISKCON shall not extend to any other activity or create a partnership between the Parties here to and under any law of any country. The parties agree that it is not their intention to share any loss or profit between them in the irrespective fields, except to the extent especially provided here in.

COSTS

1. ISKCON and BCET agree that all costs associated with specific training initiatives will be the subject matter of separate contrasts.
2. Cost to all Training activity to be borne by per student basis through BCET.

CONFIDENTIAL AND PROPRIETARY INFORMATION

1. "Confidential Information" shall mean all information, including the course material and other information if any so given to BCET, written or verbal, identified as confidential or of a nature that a reasonable person would understand as being considered confidential by ISKCON, and disclosed by ISKCON to BCET or its faculty which is related to ISKCON information such as course material, training data, guidance notes, procedures, methodology, etc.
2. BCET shall hold in trust and confidence for ISKCON all confidential information provided by ISKCON and BCET shall not disclose to any person or use such information for any purpose other than defined in this MOU. BCET shall not make any copies of the confidential information other than required for the work involved and with prior and mutual consent from ISKCON and shall return/destroy all such information at the termination of the contract. By disclosing this information to BCET, ISKCON does not grant any expressed, implied or other license or right to BCET to propagate the information. ISKCON hereby grants BCET an academic, non-exclusive, non-transferable right solely for the purpose of providing Universal Human Values training to the BCET students.
3. BCET shall not disclose ISKCON confidential information and Brand name without first obtaining written consent from ISKCON.
4. BCET shall disclose ISKCON confidential information only to BCET employees having a legitimate reason to know the same and shall inform each employee receiving the confidential information of the confidential nature of the same and BCET obligations here under.
5. BCET shall secure documents, items of work in progress and work products that embody confidential information in locked filed or are as providing restricted access to prevent its unauthorized disclosure. BCET shall maintain adequate procedures to prevent loss of any confidential information or confidential documents provided to it by ISKCON. In the event of any loss, BCET shall notify ISKCON immediately.
