- Conduct joint seminars, training, workshops, and similar events to foster knowledge sharing and professional development.
- Organize Entrepreneurship Development Programmes (EDP) of long duration to support aspiring entrepreneurs.
- 4. Undertake joint activities, studies, and projects on various sectors such as Health Sector, Infrastructure Sector, MSME, CSR Activities, etc., and report/submit the findings of the study to the Government.

Reciprocate participation in National and International Conferences organized by both institutions to promote cross-learning and collaboration on a global scale.

# Review of MoU:
